Local Streets and Roads Funding Program

Fiscal Year 2020-21 Funding Eligibility Reminder

The Local Streets and Roads Fiscal Year 2020-21 Funding Eligibility Proposed Project List-Resolution Submittals are due to the Commission on or before **May 1, 2020**. To be eligible for fiscal year program apportionments, cities and counties must submit an adopted list of projects to the Commission pursuant to Streets and Highways Code (SHC) Section <u>2034(a)</u>.

In accordance with the 2019 Local Streets and Roads Funding Program Guidelines CalSMART, the California Statewide Multi-Modal Application and Reporting Tool (CalSMART) is the only accepted submission method recognized. The submittal feature will be open from **March 20, 2020 to May 1, 2020**.

The Commission will adopt the Initial List of Eligible Cities and Counties at the June 2020 Commission meeting. Visit the Local Streets and Roads Fund Program Web-site for the annual program schedule.

Eligibility submittals must be consistent with SHC Sections 2030-2034 2019 Local Streets and Roads Funding Program Guidelines and the adopted by the Commission.

To establish eligibility the cities and counties **must**:

• Include a description, location, estimated schedule, and estimated useful life for each project proposed in the list that is adopted.

• The list of projects must be adopted by the applicable city council or county board of supervisors each year, at a regular meeting prior to submitting to the Commission.

• The list adoption shall be a standalone action item and should not take place as a part of another budgetary or project action taken.

• The adopted proposed project list-resolution must be submitted to the Commission by May 1st annually in CalSMART.

Fiscal Year 2020-21 Local Streets and Roads Road Maintenance and Rehabilitation Account SB 1 Estimates are available on the California Local Government Finance Almanac web-site. The estimates are provided by a third-party consultant that is contracted by the League of California Cities.

Central Coast Highway 1 Climate Resiliency Study Public Workshop, February 27, 2020

The Association of Monterey Bay Area Governments (AMBAG) invites you to come learn about the Central Coast Highway 1 Climate Resiliency Study. The Highway 1 corridor near Elkhorn Slough could face significant challenges to the future of transportation in the Monterey Bay region under conditions of climate change and sea level rise. Elkhorn Slough is California's third largest tract of tidal wetlands and hosts extraordinary biological diversity, providing critical habitat for more than 135 aquatic birds, 550 marine invertebrate species, and 102 fish species. Changes to the road and railway infrastructure will likely affect these important ecological resources. This multi-benefit planning study seeks to identify the needs and opportunities to improve transportation mobility, safety and efficiency, promote healthy coastal habitats, and provide economic security and benefits to the local community. Community members are invited to attend this second community open house to find out more about future adaptation strategies for Highway 1, Elkhorn Rail and Elkhorn Slough and contribute their input on the study and transportation and ecological resources in the area.

Energy Watch



Three AMBAG jurisdictions complete comprehensive LED lighting projects

In the last quarter of 2019 AMBAG Energy Watch staff worked closely with three jurisdictions to complete comprehensive LED lighting retrofit projects. These projects were funded through PG&E On Bill financing and

received AMBAG Energy Watch rebates.

The City of Carmel completed interior LED lighting retrofits at seven sites, including the City Hall, the library and the fire station. Now that this project is complete the city is saving over 70,000 kWh and over \$13,000 in avoided energy costs annually.

The City of Seaside completed a city-wide interior and exterior LED lighting project at twelve sites including the City Hall, the Oldemeyer Center and the Patullo Swim Center. Now that the project is complete the City of Seaside is saving over 400,000 kWh and over \$75,000 in avoided energy costs annually.

The City of Watsonville completed a city-wide interior and exterior LED lighting retrofit project at 26 sites, including the civic plaza, the police department, the fire stations and the airport. The project was completed in December and the City of Watsonville is now saving over 950,000 kWh and over \$130,000 in avoided energy costs annually.
